Item 8.0-Review the 2023/2024 Hall Rentals

Vice President Rodriguez highlights that our hall prices were increased almost a year ago, prompting an agenda item to evaluate any significant shifts in rental numbers or the stability of demand post-rate adjustment. The General Manager's update reveals that we have observed a rise in revenue since the adjustment, and there are still open slots to fill for the rest of the year.

• Vice President Rodriguez- is still eager to have the water tower painted and illuminated, and he also desires the presence of a representative from the Boys and Girls Club organization for consideration in our town.

Item 10. Staff Reports

General Manager, Elaine Cervantes, presents her staff report and verbally includes the following to her staff report:

- ATP Project- Engineer estimated cost of \$300,000 for 18 lights. Submitted budget request for Esmeralda Soria. Elaine submitted a letter to Mrs. Soria which she shares with the public. Elaine received news from Pacheco's office on Tuesday confirming their commitment to cover the costs of the conduits and pull boxes, resulting in a significant savings of \$150,000 for the District.
- Water System Upgrade Project- Ruben Mora of the State Water Board, stated that there are no further funds available for the project. He has granted the District a two-day window to locate any relevant correspondence pertaining to the project, with the aim of sustaining its progress and avoiding the need for reapplication.
