NEW BUSINESS-

<u>Item 3.0</u> – Fresno County Rural Transit Agency Micro Transit Project

Guest Speaker Moses Stites, General Manager for FCRTA, speaks on the success of the Biola Ribbon Cutting Ceremony and is following up with the board on the vision for the next project, the Microgrid Hub. Additionally, he is following up to move forward with upgrading the District's second gate to make it automatic.

<u>Item 4.0 -</u> Public Hearing to Consider Proposal for CDBG Funds (Resolution 2023-17)

Alfonso Manrique, AM Consulting Engineers, states \$300,000 can be awarded in County funds if the District is selected. Recommendation from staff is to apply for the replacement of 15-20 fire hydrants. The public hearing opens. There is no public input.
