Roll Call was called.

Call to Order

Board Secretary Rodriguez calls the meeting together at 6:02 p.m. Vice Chair Ramos arrives at 6:03pm. Board Chair Duarte arrives at 6:07pm and conducts the meeting.

NEW BUSINESS-

Item 3.0 – Guest Speaker-Presentation provided for District Solar and Utility Costs
Yan Purba, the CEO of Tynergy, is introduced by Board Secretary Rodriguez. Mr. Purba discusses potential solutions for reducing the District's energy expenses through the use of solar batteries.

Item 4.0 - Discussion and Consideration of the January 2020 Utility Billing Collection and Write Off Bad Debt

Stephen Huerta, CPA, briefly summarizes the January 2020 missed utility billings that were not sent out to the community due to technical issues. These outstanding billings have been recorded as receivables in the financial records, but no efforts have been made to collect them since then. The General Counsel has emphasized that the District has a legal responsibility to initiate internal collection procedures or send to collections unless a relevant policy is established, as it would not be appropriate to take any other action in this regard.

A motion is made to designate the \$37,705.97 as bad debt but still attempt to collect the amount through internal efforts or by forwarding it to collections.

Item 5.0- Discussion and Consideration of District Sponsorship of \$2,500 to the 65th Annual Biola Chamber of Commerce

Elaine Cervantes, the General Manager, mentions that this sponsorship is an annual tradition supported by the BCSD. Vice Chair Ramos then offers a comment concerning the donation.

A motion is made to donate \$2,500 to the 65th Annual Biola Chamber of Commerce.

Item 8.0- Discussion and Consideration of Stipend Payments to Board of Directs for “Days of Service” Pursuant to Resolution No. 2018-10 and Reimbursement of Expenses To Board Members

Vice President Ramos has conveyed his insights from the most recent 2023 CSDA Annual Conference, highlighting concerns about the existing reimbursement procedure and meal allowances. He suggests for the District to adopt the per diem rate for expenses. **The Board has directed the General Counsel to investigate and bring back the per diem rates and the reimbursement/expense form exclusively for Board members, and collaborate with the staff to develop a policy for the Board's consideration and approval.**

Item 9.0- Discussion and Consideration of “Chain of Command” Procedure for Board of Directors relating to District Business

Board President Duarte emphasizes to the Board that reaching out to our vendors without proper authorization is not allowed. Any inquiries or issues should be directed to the Board President, Vice President, or General Manager. If a Board member requires urgent information, they must arrange an appointment with the General Manager. **Directs staff to look for Policy and Procedures that outline the protocol for the community bank's communication with the District.**

Item 10.0- Board Member Communications

- Board Treasurer Madera spoke to Mid Valley Disposal vendor concerning a driver's misconduct in front of our office.
- Board Secretary Rodriguez updates the Board on the Water Tower painting. Direction from Board Chair to be placed on next agenda for discussion.
- Vice President Kirk presents a report to the Board about his attendance at the 2023 CSDA Annual Conference.
- Board President Duarte presents a report to the Board about her attendance at the 2023 CSDA Annual Conference assuring that she will distribute any information and pdf documents she has obtained to all board members and staff.
